Section 1519 of the same act provides that in a declaratory judgment action, "[t]he court or the jury... may hear and consider evidence that is relevant and material to the issue.... and award such relief or remedy as the evidence may warrant, or as the case may require." Thus, Section 1519 allows such introduction of evidence as is relevant and material to the issue. *371 The provisions of 35 P.S. § 1519 would seem to permit the award of alimony, given the evidence in the record regarding the financial condition of each party and the existence of a need therefor. The latter provision, of course, is wholly consistent with the determination of whether such alimony should be made permanent. The ability to provide some temporary relief in the form of maintenance would seem to be consistent with the injunction against the charging of excessive fees for permanent alimony support in the cases of *Yanch v. Yanch*, supra, 321 Pa.Super. at 544, 459 A.2d at 961, and *Jacobi v. Jacobi*, supra, 309 Pa.Super. at 33, 454 A.2d at 766. Thus, the following is a reasonable definition of the scope of the term "other relief" in this context: "Other relief" includes an order for any legal or equitable relief or remedy not covered by the definitions in subsection (a) of this section including, but not limited to, orders of alimony, maintenance and support, injunctions, and awards of counsel fees. "Other relief" includes an order for any legal or equitable relief not covered by any of the above definitions, including, but not limited to, provisions for the appointment of a receiver or a master, or provisions for the sale of a party's interest in real estate." 35 P.S. § 1501(a) (emphasis added). Thus, even though Section 1519 specifically permits evidence and testimony in this type of case to address the question of maintenance and alimony awards, the broad language of this section makes clear that a temporary award of maintenance is within the purview of Section 1519 as other relief. In our view, the trial court had ample authority under Section 1519 to make an award of alimony to Mrs. Smith. The court could properly have heard evidence to establish the need for the award of maintenance and awarded to her whatever amount of maintenance was deemed appropriate.
